

1. **THE PROMOTER**

1.1 The Promoter is St Andrews Links Trust of Pilmour House, St Andrews, KY16 9SF.

2. **THE COMPETITION**

2.1 The title of the competition is 'Old Course Challenge'.

2.2 Win a two night over-night stay in bed & breakfast accommodation at Rusacks St Andrews for the winner and a guest on Monday 8th & Tuesday 9th May 2023, and a package of other prizes as detailed below, by correctly answering one multiple choice question.

3. **HOW TO ENTER**

3.1 The competition will run from 1st May (the "**Opening Date**") to 31st May 2022 the ("**Closing Date**") inclusive.

3.2 All competition entries must be completed by no later than 5pm on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.

4. **ELIGIBILITY**

6. **WINNERS**

6.1 The decision of the Promoter is final and no correspondence or discussion will be entered into.

6.2 The Promoter will contact the winner within seven (7) days of the Closing Date, using the email address provided with the competition entry (the "**Announcement Date**"). The Promoter will not amend any contact information once the competition entry form has been submitted.

6.3 If the winner cannot be contacted, is not available, or has not responded to the Promoter within seven (7) days of the Announcement Date, the Promoter reserves the right to select a new winner from the correct entries that were received before the Closing Date.

6.4 The Promoter does not accept any responsibility if the winner is not able to take up the prize.

7. **LIMITATION OF LIABILITY**

7.1 Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees.
